## **“A Legacy Etched in Stone”**



Born in 1940 in Jelsi, Italy, Giuseppe (Joe) Panzera emigrated to Canada at the age of 16, fueled by ambition and an unshakable work ethic. Starting out as a tile installer, Joe quickly rose through the ranks, eventually launching his own construction company. His journey took a pivotal turn when he met Margaret Ciot, daughter of Giovanni Battista Ciot, founder of Ciot. Their partnership—both personal and professional—would shape the future of the company and the industry.

After marrying Margaret, Joe took on a leadership role at Ciot, transforming it from a local terrazzo shop into a North American powerhouse in natural stone, tile, and luxury design. Through his vision, Ciot introduced an expanded product range—including marble, engineered slabs, mosaics, hardwood, and luxury plumbing—and opened 10 showrooms across Canada and the U.S. The company's 100,000 sq. ft. Montreal headquarters stands as a symbol of its innovation and success.

Joe's entrepreneurial spirit extended into real estate development, where he invested in condos, commercial properties, and land. Yet despite his many business ventures, Joe remained deeply grounded in family, friendship, and community. Known for his warmth, generosity, and love of cooking, he brings people together with the same passion that built his business.

Now celebrating its 75th anniversary, Ciot continues to thrive under the leadership of the next generation, including Joe and Margaret's daughters, Kristina and Claudia. Joe's legacy is captured in his own words: “It all began with a path etched in stone.”


